

Certificate of Conformance according to RoHS & WEEE for all Matrix products

RoHS: Restriction of the Use of Certain Hazardous Substances in Electric and Electronic Equipment

WEEE: Waste Electrical and Electronic Equipment.

The RoHS Directive 2002/95/EC restricts the use of hazardous substances listed below in electronic and electrical equipment:

- We perform material content testing where appropriate
- All our electronic component suppliers have confirmed the compliance according to 2002/95/EC
- All our plastic and PCB suppliers have confirmed the compliance according to 2002/95/EC
- All our auxiliary material suppliers have confirmed the compliance according to 2002/95/EC

The confirmation of compliant status by our suppliers is either because the products do not contain any of the restricted substances referred to in Article 4 (1) of the RoHS Directive at concentrations in excess of those permitted or it is allowed as one of the particular applications listed in the Annex to the RoHS Directive. For these purposes, the maximum concentration values of the restricted substances by weight in homogenous materials are:

Lead	0.1 %
Mercury	0.1 %
Hexavalent Chromium	0.1 %
Polybrominated Biphenyls	0.1 %
Polybrominated Diphenyl Ethers	0.1 %
Cadmium	0.01 %

These values are met for all contained electronic components, plastic cases, PCB's and connectors. All Matrix products are fully compliant according to 2002/95/EC RoHS and 2002/96/EC waste of electrical and electronic equipment, WEEE and registered at EAR Reg-No. DE22126100. Additional EAR certification available.
